| 1. A–1, while airborne, catches a live ball in an attempt to prevent it from going out of bounds. A–1 throws the ball to the floor inbounds, returns to the court, and recovers the ball and starts dribbling. Official rules this a double dribble. Is the official correct?  | 1.  | Yes | No |
| 2. The home team players enter the playing court to start the game wearing their red jerseys. Official rules the jerseys are illegal and charges each starter with a technical foul. Is the official correct?  | 2.  | Yes | No |
| 3. B–1 commits his/her fifth foul and is disqualified. After the warning horn, B–6 replaces B–1. As B–6 is beckoned into the game, A–6 reports to enter the game. The timer sounds the horn. Official denies A–6 from entering the game since the warning horn had sounded. Is the official correct?   | 3.  | Yes | No |
| 4. A–1’s pass is deflected out of bounds by B–1. The official is ready to administer the throw-in but team A is huddling and no player is available for the throw-in. Official places the ball on the floor and starts the 5 second count. Is the official correct?  | 4.  | Yes | No |
| 5. Team A scores and prior to the ball being at the disposal of team B, a double technical foul is committed. Possession arrow favors team A. Official awards the ball to team B for the throw-in and rules team B may run the end line. Is the official correct?  | 5.  | Yes | No |
| 6. Team A is granted a time-out. As the teams are going to their benches, A–1 is assessed with a technical foul. Official rules that during a time-out, team members are bench personnel and charges team A’s coach with an indirect technical foul. Is the official correct?  | 6.  | Yes | No |
| 7. A–1 establishes the right foot as the pivot foot. A–1 steps with the left foot and before releasing the ball for a try for goal, A–1 picks-up his/her pivot foot. Official rules this a legal play. Is the official correct?  | 7.  | Yes | No |
| 8. The 8 non-jumpers take positions on the restraining circle. As the official is ready to toss the ball, B–3 backs straight off the circle. A–4, who was next to B–3, moves into the vacated spot. Official rules this is a legal play. Is the official correct?  | 8.  | Yes | No |
| 9. While A–1 is dribbling, A–2 commits a common foul on B–2. Team B is in the bonus. Official awards B–2 a one and one. Is the official correct?   | 9.  | Yes | No |
| 10. Several minutes into the game, the official notices that A–1’s sweatband is being worn above the elbow. The official informs A–1 that the sweatband must be worn below the elbow and he/she must either remove the item, place it below the elbow or leave the game. | 11. As A–1 enters the semi-circle to attempt a one and one, the official observes that A–1’s shirt is not tucked in his/her pants. | 13. A–1 passes to A–2. A–2’s pass to A–3, hits an official and rebounds back to A–2. A–2 then starts a dribble. Official rules this a legal play. Is the official correct?   | 13. | Yes | No |
| 14. A–1 is closely guarded in the frontcourt by B–1 for 2 seconds. B–2 now double teams A–1 so both are guarding A–1 for 1 second. B–1 then leaves A–1. Official starts a new count. Is the official correct?  | 14. | Yes | No |
| 15. During an interrupted dribble by A–1, A–1, while chasing the ball inadvertently steps on the boundary line. When A–1 catches up with the ball and touches it, official sounds the whistle and rules this a violation. Is the official correct?   | 15. | Yes | No |
| 16. While A–1’s pass is in the air to A–2, B–1 deflects the pass. Official inadvertently sounds the whistle and grants a time-out requested by team A’s coach. Official rules the time-out cannot be denied or revoked and after the time-out has expired, uses the alternating possession procedure to resume play. | 17. A–1 is fouled as the first half ends. Team A is in the bonus but the scorer fails to notify the official. The second half starts with team A making the throw-in and scores. | 18. A–1 and B–1 in the low post are called for a double personal foul while A–2 is dribbling behind the semi-circle. Official awards the ball to team A nearest the spot of the foul. Is the official correct?   | 18. | Yes | No |

| 20. A–1 scores. A–2 purposely grabs the ball, steps out of bounds and passes to A–3, who scores. While the ball is at the disposal of team B, the throw-in by A–2 is questioned. 21. Yes No 21. Space between A-2 and B-2 on the restraining circle prior to the jump ball is vacant. When the official makes the toss but before the ball is tapped, A-1 moves laterally into the space next to B-2. Official rules this a violation. Is the official correct?
22. Yes No 22. A-1 has been directed to the bench. Official informs the coach that the player must be replaced within 20 seconds with a warning horn sounding with 15 seconds remaining. Is the official correct?
23. Yes No 23. During an alternating possession procedure throw-in, A-1 releases the ball. Before the ball is touched inbounds, B-2 fouls A-2. Team A is not in the bonus. Official awards the ball back to team A and rules this is still an alternating possession procedure throw-in. Is the official correct?
24. Yes No 24. While A-1's try is in flight, A-2 fouls B-2. Team B is in the bonus. Official rules this a team control foul. Is the official correct?
25. Yes No 25. A-1 and B-1 get into a confrontation, which is handled by the officials without penalty. A-6 and A-7 leave the bench and enter the court. Referee charges A-6 and A-7 with flagrant technical fouls, one indirect technical foul charged to the coach, two team fouls which count to reach the bonus and awards team B two free throws, plus the ball. Is the Referee correct?
26. Yes No 26. While A-1's pass is in the air toward A-2, A-3 and B-3 commit a double personal foul. Official charges the fouls and awards the ball to team A nearest to the spot when A-1 was last in contact with the ball. Is the official correct?
27. Yes No 27. The referee to start the game permits the teams to go in the wrong direction. Jumper A-1 back taps the ball to A-2. As A-2 dribbles across the division line, official sounds the whistle and calls a backcourt violation. Is the official correct?
28. Yes No 28. During a foul reporting sequence, team B is issued a warning for huddling in the lane prior to a free throw. In the fourth quarter, B-1 interferes with the ball following a score. Official issues a warning for this act too. Is the official correct?
29. Yes No 29. A-1's pass from the backcourt hits A-2, who is in the frontcourt and rebounds into the backcourt. A-1 is the first to touch the ball. Official rules this a legal play. Is the official correct?
30. Yes No 30. A-1, enters the game with a multi-color, narrow elastic band around his/her head for hair-control. Official rules that this hair device is not a headband and therefore does not fall under the headband rule and is legal. Is the official correct ?
31. Yes No 31. Team A is granted a time-out. After the warning horn has sounded, A-6 reports to the scorer's table to enter the game. Official denies A-6 from entering the game. Is the official correct?
32. Yes No 32. Prior to either team gaining control on a jump ball to start the overtime period, B-2 is charged with an intentional personal foul. Official instructs the scorer to set the arrow when he/she places the ball at the disposal of the free thrower for the first free throw. Is the official correct?
33. Yes No 33. A-1 places a hand on the ring to push his/her self around to the other side of the basket to grab a rebound. Official charges A-1 with a technical foul. Is the official correct?
34. Yes No 34. A-1 is intentionally fouled on a 3 point try. The try is unsuccessful. Official awards A-1 two free throws plus the ball. Is the official correct?
35. Yes No 35. With 2/10's of a second to play in the first quarter, A-1's throw-in is caught by A-2, who tries for goal. The timer fails to start the clock. Ball enters basket. Official rules no basket stating that the period ended when A-1 caught the ball. Is the official correct?
36. Yes No 36. A-6 legally enters the court to replace A-5. As A-5 is leaving the court, A-5 is charged with a technical foul. Official rules A-5 is bench personnel and charges the coach with an indirect technical foul. Is the official correct?
37. Yes No 37. B-1 fouls A-1. It is the 7<sup>th</sup> foul of the half. As the official is ready to administer the free throw, A-1 is huddling with his/her coach and does not enter the semi-circle. The official uses the resumption of play procedure to resume play. Is the official correct?
38. Yes No 38. After a field goal by team A, B-1 has the ball out of bounds when A-2 and B-2 commit a double personal foul. Official awards the ball back to team B and rules the throw-in is a designated spot throw-in. Is the official correct?
39. Yes No 39. A-1 and B-1 begin to fight while the ball is dead. A-6 and A-7 enter the playing court. B-6 also enters the playing court and begins fighting with A-6. Official charges A-1, B-1, A-6, A-7 and B-6 with flagrant technical fouls, team A coach with two indirect technical fouls, coach B with one indirect technical foul, team A with three team fouls, team B with two team fouls and awards team B two free throws plus a throw-in at the division line opposite the scorer's table. Is the official correct?
40. Yes No 40. Following a score by team A, B-1's throw-in is intentionally kicked. Official awards the ball back to team B and rules the throw-in is a designated spot throw-in. Is the official correct?
41. Yes No 41. Prior to A-1 releasing the ball on a free throw, B-1 is charged with a disconcerting act. A-1's free throw is successful but A-1 commits a free throw violation. Official cancels the free throw and awards A-1 a substitute free throw. Is the official correct?
42. Yes No 42. During an interrupted dribble by A-1, A-2 commits a common foul on B-2. Team B is in the bonus. Official awards B-2 a one and one. Is the official correct?
43. Yes No 43. During an alternating possession procedure, A-1, the thrower-in, places the ball through the boundary line. B-1 grabs the ball and a held ball is called. Official awards the ball to team B, stating that when the ball was touched the arrow changes. Is the official correct?

A-1, in the frontcourt, jumps into the air, intercepts the pass and lands with one foot touching in the frontcourt, with the other foot coming down in the backcourt. Official rules this a legal play. Is the official correct?
73. Yes No 73. Team A is granted a 30 second time-out. Fifteen seconds prior to time expiring, the timer sounds a warning horn. Is the timer correct?
74. Yes No 74. During an alternating possession throw-in, A-1's throw-in is intentionally kicked. Official awards the ball back to team A and rules this is still alternating possession throw-in. Is the official correct?
75. Yes No 75. Team B, was issued a warning for interfering with the ball following a score. Later in the game, B-1 breaks the plane of the boundary line on a throw-in and fouls A-1. Official charges team A a technical foul for delaying the game and charges A-1 with an intentional personal foul for fouling B-1. Is the official correct?
76. Yes No 76. A-1, who has the ball in the frontcourt passes the ball toward A-2. B-2 bats the ball to the floor in A's frontcourt so it bounces toward the backcourt. 81. Yes No 81. With 5 seconds on the shot clock, A-1's throw-in is intentionally kicked. Official awards the ball back to team A and instructs the shot clock operator to set the shot clock to 15 seconds. Is the official correct?
82. Yes No 82. While A-1's second free throw of two is in flight a double personal foul is assessed. The try is successful. Official counts the free throw and resumes play with the alternating possession procedure. Is the official correct?
83. Yes No 83. A-1, closely guarded in the frontcourt, holds the ball for 3 seconds then has the ball batted out of his hands. As A-1 is about to recover the ball, official calls a 5 second closely guarded violation. Is the official correct?
